Approved recommendation 4 to allow for managers to feed back a team into a tournament if an injury occurs. (11-0)

Rejected recommendation 6 to increase mat size. (0-11)

#### **E. Boys/Girls Swimming and Diving**

##### Terms and Conditions:

Approved recommendation 1 qualifying times for advancement of winners. (11-0)  
Approved recommendation 2 to let all sectional championship teams be one of the teams that enter the deck first. (11-0)  
Approved recommendation 3 to not allow a diving judge to be from any school that has an entry (11-0)

#### **F. Boys/Girls Basketball**

##### Terms and Conditions recommendations:

Approved the recommendation to drop the high and low seed of a school in the sectional complex seeding. (11-0)  
Also recommended that this concept be applied to all sport that have a sectional complex seeding.

##### Administrative recommendations:

Approved the recommendation to drop the slam dunk contest in basketball. (11-0)

##### Discussion:

Had some concerns with when the random drug testing would be conducted at a school next year. Concerns focused around students being taken out of class for testing. They would recommend after school as the testing time.  
Talked about restructuring the 3 point shooting contest. Recommended that it go to one day event to help eliminate travel for schools and coaches. Would like for this concept to be looked at by the IHSA.

#### **G. Boys/Girls Soccer**

##### Terms and conditions:

The committee approved recommendation 1 (11-0)  
The committee modified recommendation 2 to start at 4:00 not 4:30 and approved this (11-0)  
The committee rejected recommendations 3 and 4 (0-11)  
The committee modified and approved recommendation 5 penalty for not submitting a season summary form to read that the penalty will be that the head varsity coach is suspended from the IHSA state series tournament. (11-0) This should be applied to all sports not just soccer.  
The committee approved recommendation 6 as modified to list season summary in chronological order for all sports not just soccer.  
The committee approved recommendation 7 to have PK's end the 3<sup>rd</sup> place game at state. (11-0)

State Association Adoptions:

Approved recommendation 1 that if overtime is not discussed prior to the game the game will end in a tie. (10-1)

Tabled 2 to get further information on how to get this done. Thought Scott Johnson needed to provide input on this recommendation. (11-0)
