**Return Times**

In accordance with a recommendation that was approved by the IHSA Board of Directors, competing boats at the IHSA Bass Fishing State Finals will be assigned a flight 'return' time each day of the state finals. The return time will be based on a boat's launch number and will possibly vary by day. Use the key below to find your boat's return time each day. Boats that are late returning will be penalized as outlined in the T/C's.

- Return Flight 1: 3:00 p.m. return time
- Return Flight 2: 3:15 p.m. return time
- Return Flight 3: 3:30 p.m. return time


**NOTE:** In accordance with a recommendation approved by the IHSA Board of Directors, three days prior to the official practice date for the state finals tournament, no coaches, boat captains, or team members of any qualifying school may be on the water at the state finals site.
