MINUTES OF THE IHSA OFFICIALS ADVISORY COMMITTEE MEETING September 6, 2023

Associations can request grants up to \$500. Those approved must turn in receipts for the agreed to purchase(s) prior to June 30, 2024, to receive payment from the IHSA.

Items of Discussion

- 1. The committee reviewed the minutes of the committee's April 2023 meeting and the action taken by the IHSA Board of Directors following that meeting.
- 2. IHSA staff reviewed the function of the committee and the process followed by the IHSA Board of Directors to make change and approve recommendations.
- 3. The committee heard a report from IHSA staff concerning this summer's Officials Conference.
- 4. The committee heard a report from IHSA staff regarding officiating licenses already distributed this year. At this point, registration numbers appear to be up year over year from 2022-23, and IHSA will continue to monitor trends as the year continues.
- 5. The committee heard a report from IHSA staff concerning new initiatives begun this year, including:
 - a. The change in licensing fees for the current year
 - b. The partnerships IHSA has formed with Officially Human and RefReps
 - c. The change in registration for out-of-state officials form bordering states
 - d. The formation of a sub-committee to examine the post-season assigning process; the committee heard that to allow officials an opportunity to offer their insight into this important topic, a portal will be created to allow officials and schools to share ideas.
 - e. The plans for IHSA staff to examine the post-season pay structure to determine what, if any, adjustments shall be made for the 2024-25 school year
- 6. The committee reviewed grant requests from a number of officials associations, giving thoughtful consideration to each. A list of those grants recommended for approval by the IHSA Board of Directors are listed previously in the recommendation earlier in these minutes.
- 7. The committee discussed whether there would be any possibility for IHSA to develop a formal relationship/partnership with Hudl that may provide associations with opportunities for greater exposure and use of the platform.
- 8. The committee discussed at length the importance of association membership for individual officials. The committee discussed multiple benefits that could be provided associations, all done with the intent of improving attendance and participation at the association level. The committee believes this topic needs further consideration, and this topic will be on the agenda when the committee meets again in the spring. Among the ideas discussed by the committee were:
 - a. Allowing associations who meet a specific attendance benchmark have the ability to submit a List of Top Officials.
 - b. Allowing associations who meet a specific attendance benchmark be allowed to identify a person from the association who can make officials' ratings.
 - c. Require officials to be a member of an association and meet attendance benchmarks in order to be eligible for post-season assignments.
- 9. The committee heard an update from the IESA Associate Executive Director Chris Frasco on sportsmanship efforts being undertaken by the IESA. Among those included increased reporting on social media of positive examples of sportsmanship, the distribution of special 'sportsmanship medals' to students following IESA state series events, and a new penalty structure for ejections that includes, in some cases, fines assessed.
